The Executive Order about Invoking the Insurrection Act:

Rump requested a report 90 days from taking office (April 20th) from DHS Secretary Kristi Noem and Defense Secretary Pete Hegseth to know whether or not he should invoke the Insurrection Act (note it says "Declaring a National Emergency at the Southern Border" and note he just issued an Executive Order declaring a National Emergency at the Border last Friday, April 11th (see below)

The Us Won't Return Kilmar Abrego Garcia

*Rump lied and after the Supreme Court ruled that he must return Kilmar (a Maryland father wrongfully deported to El Salvador), a day after saying he **would bring back** Kilmar if the Supreme Court ruled on it, he said he has no jurisdiction to bring him back.
